Amendments/Additions to Agenda:

Streets/Maintenance: Luke M. said the wall packs on the outside of the Fire Station are no longer working properly, so instead of replacing them Tipmont will put new lights on the poles near by which will light up the area better.

Water/Sewer: Earl Heide not present.

Town Marshal: Jeremy Minor not present.

Clerk/Treasurer: Alaathea F. presented Accounts Payable Voucher Register for February 2, 2021 to the Board, Minnie H. made the motion to approve the APV Register, Carmine A. seconded the motion, Luke M. called for a vote, motion carried.

Alaathea F. presented the bank reconcilements for December 2020.

Alaathea F. presented the Board with up-to-date Fund Report, Appropriation Report and Revenue Report. Alaathea F. said we will be having a Work Session on February 4th at 10 a.m. at the Town Hall with the Grant Administrator and Midwestern Engineers.

Alaathea F. presented the Town Council with a draft copy of the Animal Ordinance 2021-1 to look over and give feedback, she also emailed a copy to the Town Attorney Rob Reimondo.

Alaathea F. asked permission to pay PEN Innovative Consulting for \$475.00. Minnie H. made the motion to approve the payment of \$475.00, Carmine A. seconded the motion, Luke M. called for a vote, motion carried.

Alaathea F. asked the Town Council to think about using Rebecca Scott for a consultant for the streets. She is experience with the LTAP program for reporting the necessary information to be able to be approved for Community Crossings grants in the future.

New Business:

Fire Station roof: Alaathea F. said we can do some additional appropriations from the Public Safety Fund and Cares Act Fund to use towards the new roof on the Fire Station, we need to get estimates for a dollar amount of the cost. Carmine A. said he would call someone to come out and look at the building to see what we need.

New Richmond Old Park on Osage Street: Carmine A. asked Roger Kunkel If he was able to get a flag pole for the Old Park. Roger K. is still looking into that. Luke M said we could put some benches in the park. Alaathea F. said we have a small budget for the parks, can we get some donations. Carmine A. said he would check with Home Depot to see if they would donate some treated lumber and make some calls for donations.

Minnie H. said there was a lady in Town who needed some assistance with getting some snow removed out of the front of her drive way. Luke M said he would take care of it.
