ORDINANCE NO: 2021 – 12

AN ORDINANCE ESTABLISHING SALARY AND COMPENSATION FOR ELECTED OFFICIALS AND EMPLOYEES FOR THE CALENDAR YEAR 2022.

WHEREAS, IC 36-5-3-2 states the town legislative body shall fix the compensation of its own members, the town Clerk-Treasurer, the town marshal and other town officers and employees.

WHEREAS, the Town Council wishes to establish the salaries that shall be effective January 1, 2022. New pay rate starts on the first pay period of the new year.

THEREFORE, be it ordained by the Town Council that the following salary schedule shall be in full force and effect January 1, 2022.

TOWN COUNCIL PRESIDENT: The Town Council President shall receive a salary of \$2900 per year. Town of New Richmond shall pay the following bi-annually amounts in June and December.

Town General Fund: \$600.00
Town Water Operating: \$425.00
Town Wastewater Operating: \$425.00
Total: \$1450.00

TOWN COUNCIL MEMBERS: The Town Council Members (2) shall each receive a salary of \$2400 per year. Town of New Richmond shall pay the following bi-annually amounts in June and December.

Town General Fund: \$600.00
Town Water Operating: \$300.00
Town Wastewater Operating: \$300.00
Total: \$1200.00

CLERK-TREASURER: The Clerk-Treasurer shall receive a salary of \$25149.80 per year. Town of New Richmond shall pay the following bi-weekly amounts:

Town General Fund: \$307.06
Town Water Operating: \$330.12
Town Wastewater Operating: \$330.12
Total: \$967.30

Professional Certifications or educational advancements that are achieved by the Clerk-Treasurer can earn an additional \$100.00 per certification or advancements paid out on the first pay period in December following the year of the certification(s) or advancements. Divided equally among the General Fund, Water Operating and Wastewater Operating.

Longevity pays: Clerk-Treasurer who have completed a specified number of years of service, and who have not taken the elective waiver for this benefit will be paid a longevity benefit according to the following schedule, to be paid out on the first pay period in December
