Roll Call: Board Members Present, President Luke Martin, Council Members Rebecca Scott, Minnie Howard, Clerk/Treasurer Alaathea Foust, and Marshal Jeremy Minor.

Amendments/Additions to Agenda: Community Yard Sale

Roger K. said the Township need to have an idea what the cost will be to replace the insulation. Alaathea F. said she thought the last estimate was about \$16,000.00.

James Cowherd asked about putting gravel on the town's right away by his house. Luke M. said we need to wait until our street project is done before we do anymore gravel on right away and alleys.
