

ORDINANCE 2023-6

2023 OCRA WATER PROJECT FUND 6106

WHEREAS, the Town Council of the Town of New Richmond, Indiana is, pursuant to I.C. 36-4-6-18, authorized to pass ordinances and resolutions regarding the control of the Town's finances and the appropriation of money; and finds the need to create a 2023 OCRA Water Project Fund 6106.

Now, Therefore, the Town Council of the Town of New Richmond, Indiana, Ordains and Enacts the Following:

- 1) **Creation of the 2023 OCRA Water Project Fund.** A new non-reverting fund to be known as the 2023 OCRA Water Project Fund ("Fund"), and which is to be given number 6106, is now established. The Fund shall receive monies from OCRA (Indiana Office of Community and Rural Affairs) and other sources that are required to be received into the fund.
- 2) **Purpose.** All expenditures related to this water project and what is required to be spent out of this fund. The "Fund" is a non-reverting fund, any monies will be returned to who they are required to be returned to if needed.
- 3) **Construction of Clause Headings.** The clause headings appearing in this ordinance have been provided for convenience and reference, and do not purport and will not be deemed to define, limit, or extend the scope or intent of the clauses to which the headings pertain.
- 4) **Repeal of Conflicting Ordinances.** The provisions of all other ordinances in conflict with the provisions of this ordinance are of no further force or effect, and are now repealed.
- 5) **Severability of Provisions.** If any part of this ordinance is held to be invalid, such part will be deemed severable and its invalidity will have no effect upon the remaining provisions of this ordinance.
- 6) **Duration and Effective Date.** The provisions set forth in this ordinance become and will remain in full force and effect (until the project is done and the fund is no longer needed) on day of the passage and adoption of this ordinance by signature of the executive in the manner prescribed by Indiana Code § 36-4-6-15, 16.
